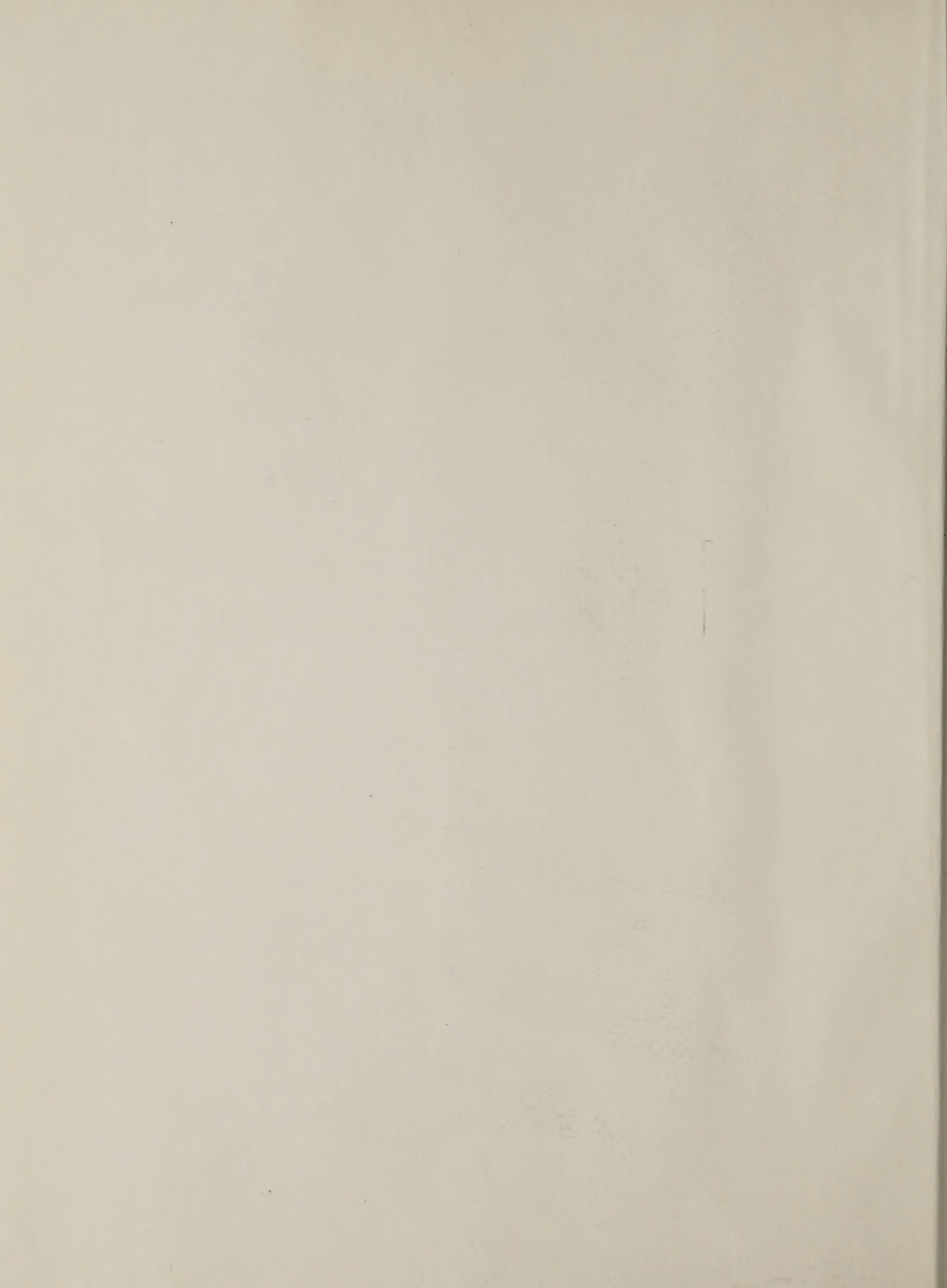

## ABAL ABEL ABELS ABEELS ABELL

- Abal, There is a Teutonic word "abal", signifying strength, which may be more probably that which is found in the French "abeillard", with which we have a name Ablard to correspond.
- Abel, Many old Testament names such as "Abel", may be connected with Medieval spectacles (plays).
- Abel, Baptismal "the son of Abel". Much more popular in medieval society than in the 19th. century among the peasantry, however, Abel still receives a certain amount of attention as a front name.
- Abel, Hebrew. Denotes breath and evanescence.
- Able, Hebrew. Denotes breath-emanation.
- Abell, Is sometimes taken from Abeele.
- Abell, A name which has not a very genuine sound of a surname.
- Abell, Is on the Roll of Battle Abbey, 1080-86.
- Abell, As the name of an under-tenant in the county of Kent, as given in the Domesday Survey.

## ABELL

### ORTHOGRAPHY OF THE NAME

Considerable confusion has resulted in the alteration of the form of the name, both by members of the families themselves and perhaps to a large extent by general usage or indifference.

In the half century period preceding the Revolution nearly all branches of our lines appear to have omitted the final ell "l". It may have been in accord with a spirit of simplicity prevalent in Puritan life and institutions and could not have been of mere ignorance or carelessness, as the signatures on wills, deeds and other public documents of the period will certify. The signatures of our immigrant, Robert Abell, and those records under his control, always appear in the form of "Abell", which has more recently been confirmed by discovery of the will of his father, George Abell, of Leicestershire, England. In the "History of Rehoboth" by Leonard Bliss, Jr., occur several references to Robert Abell, spelled with the double ell "ll", and on page 26 is appended the following note: "In transcribing the names in the list, as in most of the extracts from the ancient records, I have followed the orthography of the original". In most branches where the final ell "l" was omitted, the double ell "ll" form has been resumed within the last century, especially by those removing and settling in new locations while in others the single ell "l" continues to the present day. The latter form "Abel" appears to be originally correct for people of German, Hebrew, Scandinavian and some other nationalities, whose number in America far exceed the combined Abell family lines.

### PRONUNCIATION OF THE NAME

Brief comment may also appropriately be made, on the matter of pronunciation. It will be news to the great majority of us that more than one pronunciation can be made of this name. However, the pronunciation as given for John Abell *Ā-bēll'*, noted singer of the period of Charles II, is becoming more and more popular among the Abell families in America. In addition to the record of Norman-French adoption into England, and the historic symbol of the bell with letter A used in various forms by many members of the families, unknown to each other and unaware of its antiquity, may tend to verify it as the original and correct pronunciation as well as the form of the name. We may well claim this to be true in the case of Thomas Abell, the martyr, whose indelible memorial carved upon the wall in the Tower of London remains to attest.

## EARLY ABELLS IN ENGLAND

### A Death Sentence

When King Henry the Eighth, of marital memory, decided to divorce Catherine of Aragon, his first wife, he gave the earliest intimation of a failing which later developed into a habit. The steps he took to give an air of legal sanction to his divorce were actuated more by fear of Holy Church, and Catherine's royal parents, than a desire to consider the lady's feelings.

While anxious to appease the powerful opposition outside of his realm, he exhibited scant consideration for those of his subjects who dared to oppose him. Notable among the champions of Catherine's cause was one Thomas Abell, who, because of his courageous defence of the Queen, was executed by order of King Henry, under circumstances of unusual cruelty. It has not been given to many men to suffer death in a cause more chivalrous.

But the versatile and gallant Abells were, from very ancient times, ever in the fore-front of great historic events, and to be in the fore-front in ancient days, whether in peace or war, was to be in danger. Danger in war from enemy weapons, danger in peace from the whims of capricious princes and profligate kings. In proof of this, witness the experience of John Abell, who became a favorite at the court of Charles the Second.

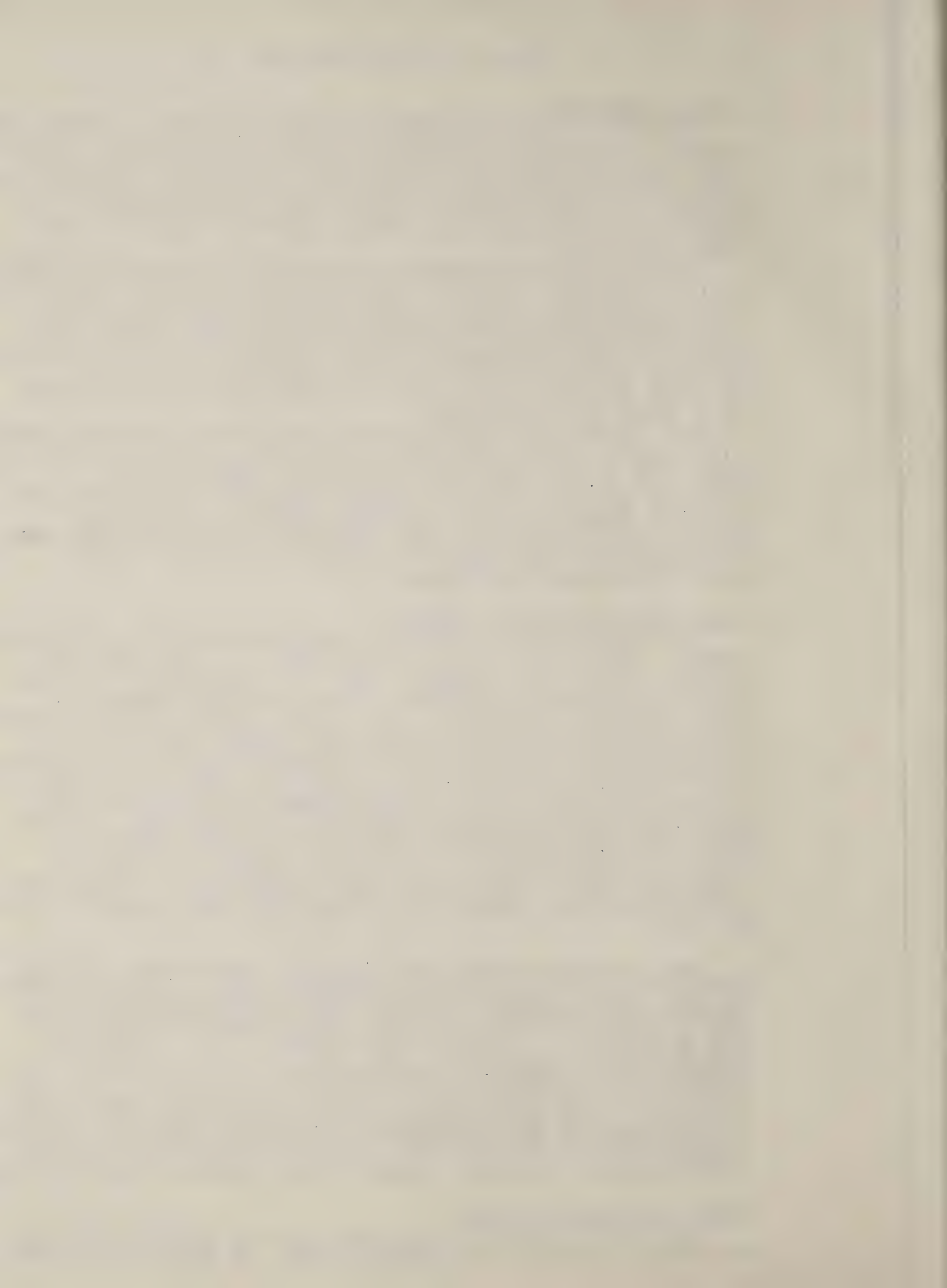
### The Courteous King of Poland

John Abell (c1660-1715) was a distinguished musician and singer. He belonged to the Royal Chapel in the reign of Charles II and his brother, James II. Dismissed at the Revolution, he sought sanctuary abroad. While in Warsaw the King of Poland, hearing of his musical talent, sent for him, but Abell refused to go. Peremptory orders were given to compel his attendance. When he arrived at the King's palace, they forcibly seated him in a chair in a large hall and hoisted the chair up to a great height. The king and his suite appeared on a raised gallery opposite Abell. Several wild bears were turned into the hall, and the King bade Abell to take his choice, either to sing or be lowered among the bears. Abell, wise man, preferred the first, and afterwards said, whimsically enough, "I never sang better in my life".

The earliest recorded event, so far discovered, of the family name is in the roll of knights and men-at-arms under William the Conqueror in 1066. This is preserved in Battle Abbey, England, where the name is inscribed in this form and spelling-viz., Abell. Duke William, after he gained possession of England by conquest, and in order better to protect his followers in their right to the soil, sent commissioners into each county to accumulate exact statements of the property and revenue of the conquered kingdom. These inquiries or surveys were completed in 1088 and afterwards arranged in proper order in the record called Domesday.

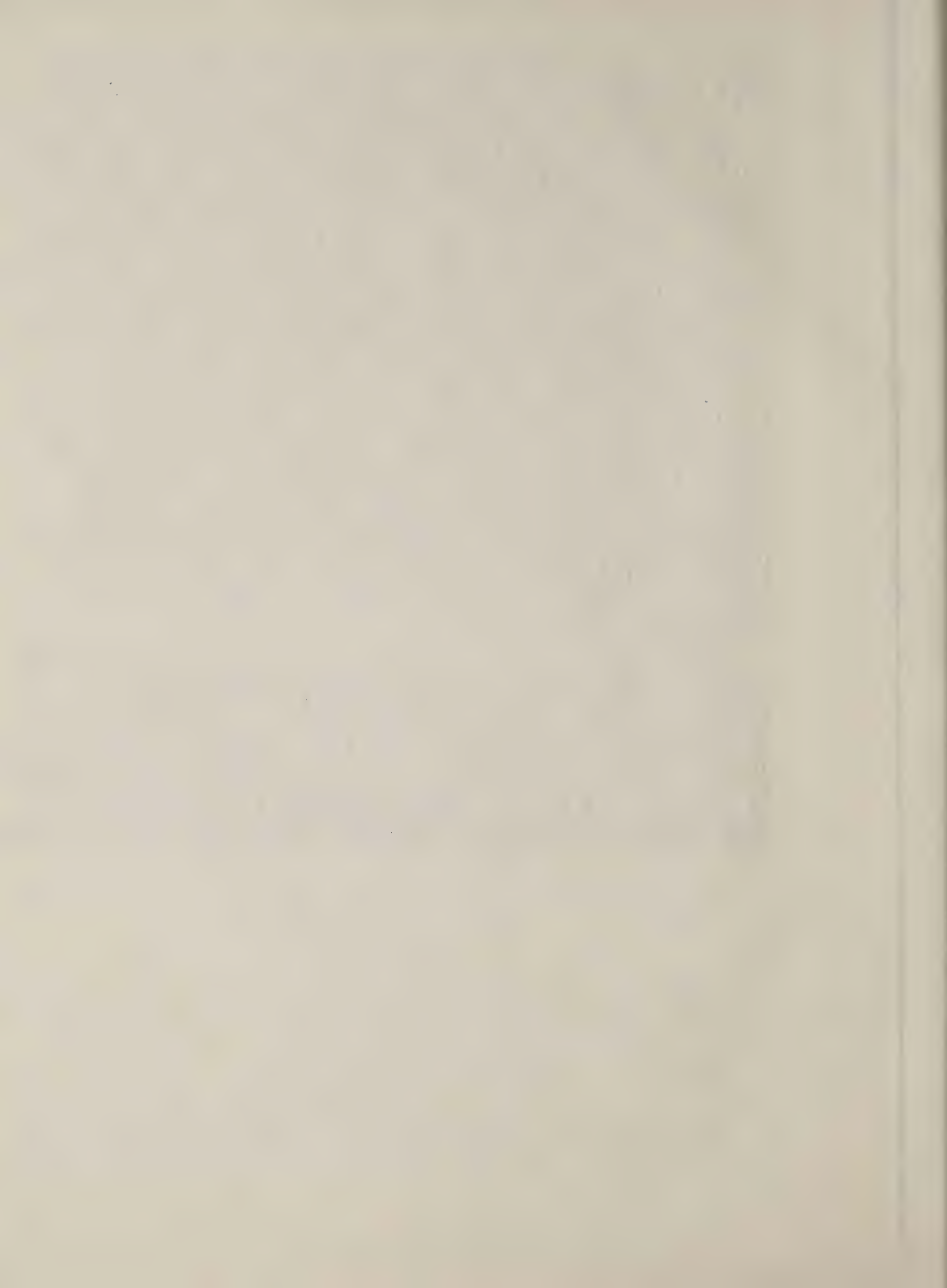
### Abell in Domesday Book

We find the name of Abell inscribed in Domesday Book as an under-tenant in the county of Kent. He doubtless was the



progenitor of the English Abells who flourished in various parts of England from the conquest to the Stuart period and to the present time. We find the next record of the family in the form of a "summons" from King Edward I, dated 1272, to John Abell and his wife, Sue, of Kent, to attend the coronation of the King and Queen at Westminster. This was probably the same Sir John Abell, of Hering Hill, in Erith, afterwards knighted at the siege of Carlaverock, who was sheriff of Surrey and Sussex in 1298, 1299, 1300, and 1301; and left two sons; John, one of the Barons of the Exchequer, and Walter, the owner of Foot's Cray; probably of knights eligible to be called to the council of the nation. One of his descendants, John Abell, died possessed of Hering Hill, about the latter end of Queen Elizabeth's reign; but his son Samuel was the last of the family there. A branch remained in Buckinghamshire, where six of the Abells lie buried in East Claydon Church. In 1276, William Abell is a witness to a sale of land in Castle Bromwick. In County Warwick, in the same place, Richard and Thomas Abell owned land in 1353 and 1362, and John and Isabel Abell registered at the Guild of Knole in 1459. During the reign of Henry VII (1485-1509), another John Abell was the progenitor of the Suffolk and Essex Abells, and we find William Abell a noted artist, decorating the interior of Warwick Cathedral about 1500, and in 1540 Thomas Abell, mentioned above, lost his head. John Abell who died in 1558, held the Manor of Cooke's Hall, of the Queen as of her Honour of Clare. In 1666, one of his descendants William Abell was living at Fordham, in the same county.

Robert Abell, Esquire, was living in Bryslingcote, County Derby, in 1517. He was a tenant of Sir William Gryseley. His grandson, George Abell, matriculated at the University of Oxford, in 1578. In 1636, William Abell, of Northampton, was an alderman of London and in the year following, High Sheriff. In this latter capacity he became cordially unpopular for his attempt to enforce the King's unjust taxation scheme. Because of this, he was forced, during Cromwell's Protectorate, to seek refuge in Holland. A few years later, John Abell, of the bear adventure in Poland, returned to the Court of Charles II.

ARMS: Argent a Saltire engrailed Azure charged with nine fleur-de-lys Or.

ARGENT.	Silver--the Field of the Shield.
A SALTIRE.	an X shaped cross.
ENGRAILED.	With pointed edges.
AZURE.	The color of the Saltire, viz-Blue.
CHARGED WITH.	Super-imposed thereon.
NINE FLEUR-DE-LYS.	French Lillies.
OR.	Gold, the tincture of the Fleur-de-lys.

The above is the literal interpretation of the Abell blazon as quoted from the Derbyshire visitation of 1569.

The Abell escutcheon is a perfect example of authentic heraldry and is, in accordance with the ancient laws of blazonry, correct in every heraldic detail of line, color and design. Argent or Silver, upon a shield signifies the purity and high resolve of the bearer. It also demanded of all his descendants the pledge that the family escutcheon shall forever remain without stain.

The Saltaire, is actually the Cross of Saint Andrew. Ancient families were prone to adopt certain saints as their family spiritual guardian, and embodied the Saint's heraldic device in their family arms. Evidently the Abells of old favored St. Andrew, hence the presence of the Saltaire upon their shield. The Saltaire is to be found in very many Scottish coats as St. Andrew is the patron saint of that country.

Fleur-de-lis signify that the Abells were originally of Norman-French origin and they, in all probability, settled in England during the Norman invasion. The presence of the Fleur-de-lis so prominently on the Abell escutcheon signifies that they were held in very high esteem by the Norman rulers, for only those families of the very noblest rank were given the privilege of bearing the Fleur-de-lis, which was the chief heraldic device on the escutcheon of the early Norman-French kings. It was a very rare distinction for them to share this device with others.

The fact too, that the fleur-de-lis are of gold tincture is evidence of the highest honor. The notable thing regarding these fleur-de-lis on the Abell shield is the fact that they are accurately placed upon the saltaire. viz; all points pointing to the chief, top, or honor point of the escutcheon. Every so many of those shields having such devices show them wrongly placed.

The Abell arms are undoubtedly of very ancient origin and such charges as are borne upon their shield could only have been displayed by a family of more than ordinary power and privilege.

EARLY ABELLS IN THE COUNTY OF DERBY, ENGLAND

Several branches of the Abell family lived in the County of Derby, England, in the sixteenth century. One branch lived in Creighton and Uttoxeter. The brothers John and Richard Abell, were the progenitors of this branch. Richard died before 1536. Henry Abell who died in 1540, was the earliest known of another branch living in Sommersall. A third branch of the Abell family lived in Norbury. The earliest found of this branch was Nicholas Abell who died about 1557. Most of the American Abells are descendants of Robert Abell, who lived in Stapenhill also in the County of Derby. There is a probability that all the branches of the Abell family in the County of Derby were descendants of a common ancestor.

The pedigree marked \*\* is recorded in official register of the College of Arms, at London, England.

Named c. 1533-8 as of Stapenhill in Chancery Proc. Early 725/38, 738/10. Mentioned in a deed 1 July 1 Edward VI and in the Will of his son George 1596.

A Robert Abell, gent., was servant or tenant to Sir Wm. Gryseley and was at Bryslincote, co. Derby, in 9 Henry VIII (1517/8). Star. Cha. Pro. 19/159.

Anothony Abell, of Ticknall, co. Derby. Mentioned in Will of Edward Draycott of Ticknall 1556. Will dated 29 May 1559, proved 3 June 1 Eliz., at Lichfield. To be buried at Ticknall. His Will dated 6 Sept. 1630, proved 7 February 1631 (PCC). Buried at Lockington 13 September 1630. Named brothers Andrew Cotton of Combermere, Chester, gent., and George Cotton of same, Esquire, executors. Frances, mentioned in her husband's Will 1630, as then alive Daughter of Richard Cotton of Combermere, co. Cheshire. Andrew and George Cotton, mentioned in George Abell's Will 1630, were the sons of Richard Cotton of Combermere.

ABELL FAMILY IN AMERICA

\*\* 4. ROBERT ABELL, of Rehoboth, in the County of Bristol, Province of Massachusetts.

Son of George and Frances Abell, of Stapenhill, co. Derby and of Hemington, co. Leicester, England. Mentioned in his father's Will 1630, as then in New England. Born in England; died at Rehoboth, Massachusetts, June 20, 1663; married Joanna -----; died after 1682; buried probably in Norwich First Burying Ground. She married secondly, William Hyde of Norwich, at Rehoboth, Mass., June 4, 1667.

Robert Abell came to America probably in the fleet with Gov. Winthrop, which arrived at Charlestown, Mass., June 1630.

The first record of Robert in America is at Weymouth, Mass., he is included in a list who were desirous to be made a Freeman October 19, 1630 and he took the Oath of Freeman May 18, 1631.

He is mentioned at the Quarterly Court, held at Boston Dec. 4, 1638 and June 2, 1640. At Weymouth he is mentioned in regards to land own by John Ffussell, John Stable and James Snooke, Oct. 26, 1642 to May 21, 1644.

Robert removed from Weymouth, Mass., in 1643, probably following Rev. Samuel Newman, the founder of Rehoboth, Mass. Rev. Newman was minister at Weymouth for four and a half or five years and then with a majority of his congregation, in 1642 removed to a place called by the Indians Seekonk, to which he gave the name of Rehoboth.

The first meeting of the original planters of Rehoboth, to be found on record, is dated at "Weimoth" the 24th of the 3th month (October) 1643, the next meeting of the proprietors was held at Weymouth, the 10th day of the 10th month (December) 1643. About the year 1643 a joint agreement was made by the inhabitants of Sea-conk alias Rehoboth, for the bringing in of their estates; that so men's allotments might be taken up according to person and estate also for carrying on of all public charges both for present and future; furthermore the means and interest of what is here expressed is that by which lands, now granted by the Court of Plymouth to the town, is to be divided according to person and estate, as is expressed in a list of 58 names. The 23th name on the list is Job Lane (underneath written) "now Robert Abell's," L50, it is evident that Robert Abell was written in after he had bought of Job Lane.



At a meeting of the town Feb. 18, 1646, it was agreed to draw lots for the new meadow, and to be divided according to person and estate; only those that were under £150, estate to be made up 150. Robert Abell is the 41st name on a list of 46 who drew for lots.

The 26th of the 12th mo., 1651, it was agreed that Robert Abell and Richard Bullock should burn the commons round about, from the Indian fence, all on the neck, and so far about the fresh meadows as may be convenient; and they are to have 20s, for their pains, and to begin the 15th of March next, and to be paid out of the first rate.

The 28th of March 1653, it was concluded and agreed upon, that Robert Abell should have three acres of meadow on the north side of the line, next the town, next the line that parteth the land of the purchasers and the town of Rehoboth. This meadow was given them by Mr. Prince, Captain Standish and Mr. Winslow.

Mention is made of Robert Abell in Court Orders, June 29, 1653, June 10, 1661 and Apr. 22, 1662.

On Feb. 1, 1654, at a town meeting, Robert was ordered to keep the Ordinary, and on July 3, 1656, Plymouth, he is allowed by the Court to keep an Ordinary at Rehoboth.

Robert was at the Court of Elections at Plymouth, June 3, 1657 and on Jury at the General Court at Plymouth, June 4, 1657. He took the oath of fidelity in 1657.

On June 22, 1658, at a town meeting, lawfully warned, lots were drawn for the meadows that lie on the north side of the town in order as followeth, according to person and estate. Of the 49 names on the list, Robert Abell was the third on the list who drew for lots, it appears that this division was of land afterwards included in the North Purchase, near Attleborough and Cumberland.

At a town meeting on May 26, 1668, lots were drawn for the meadow lands in the North Purchase and there were 79 names on the list who drew for lots. Samuel Luther is the 2nd on the list, Goody Hide the 5th, Children's lands the 6th, and Preserved the 8th. Samuel Luther married Mary, daughter of Robert Abell. Goody Hide is Robert Abell's widow (Joanna) who married William Hyde in 1667. Preserved Abell was Robert Abell's son. Children's Lands next to Goody Hide on the list are probably Robert's other children, Caleb, Joshua, Benjamin and Experience.

✓ An Inventory of ----- estate of Robert Abell of Rehoboth Deceased taken the 9th of August 1663. The only real estate was "an house and land" £130, The sum total is £354, 17s, 9d. The house and land taken out as the oldest sonnes £130; A bed and furniture to the widdow £7; To Mary Abell given by her father as her full pte in a Cow and feather bed £8; Rests Due to the widdow as her thirds £66, 19s, 6d; and to the other five Children each of them £26, 16s.

The appraisers were Stephen Paine, Thomas Cooper and Peter Hunt, were deposed to this Inventory the 18th of Feb, 1663 before Thomas Willlett. This division of the estate was approved of and established by the Court held at Plymouth the 3rd of March 1663, attested by Nathaniel Clarke of the said Court.



Administration granted unto the widow, Joanna Abell to administer on the estate of Robert Abell deceased Feb. 29, 1663-4.

Captain Willett is requested to administer an oath to Widow Abell of Rehoboth for the tenth of the inventory of the estate of Robert Abell deceased Oct. 5, 1663.

Some records mentioned a James Abell marrying Sarah Bowen, Dec. 27, 1686, this appears to be incorrect. The original vital records of Rehoboth, states that Sarah Bowen married Preserved Abell, Dec. 27, 1686. The vital, probate records and register of deeds do not list any individual by the name of James Abell. No record has been found that shows the name of this child.

**HYDE FAMILY:** After the death of Robert Abell, his widow Joanna, married William Hyde of Norwich, Conn., at Rehoboth, Mass., on June 4, 1667. William Hyde probably came to America in 1633 with the Rev. Thomas Hooker, the first minister of Hartford; sojourned a short time at Newton, Mass., and removed with him to Hartford, in 1636. The time of his removal to Saybrook is not ascertained but he owned lands in Hartford as late as 1639. He probably went to Saybrook soon after that. William Hyde was one of the original proprietors of Norwich in 1660. He was a man of considerable importance among the settlers of Norwich, and was frequently elected as one of the townsmen or selectmen. He died at Norwich January 6, 1681. No information has been obtained as to the name of his first wife, or when or where she died. Two children by his first wife, Samuel Hyde and Hester Hyde.



5. SERGT. CALEB ABELL, of Norwich, Conn., b. 1646, prob. in Rehoboth, Mass.; died August 7, 1731. Monument in Norwich First Burying Ground. Married Margaret Post, July 1669 in Norwich; born Feb. 21, 1655 in Saybrook; died Nov. 1700 in Norwich; daughter of John and Hester (Hyde) Post. Married secondly Mary (Miller) Loomer, June 25, 1701; born 1637; died after Aug. 7, 1731; daughter of George Miller and widow of Stephen Loomer, of New London, Conn.

Sergt. Caleb Abell is first mentioned in the Colonial records at Dedham, Mass., when he petition for Freeman on May 3, 1665, in 1668 he moved to Norwich, Conn., where he married the following year. In the original purchase of land when Norwich was settled, six acres having 16 rods front, was assigned to Robert Wade, this he sold to Caleb Abell in 1677 and it was afterwards known as the Abell homestead. This property abutted on Town Street 16 rods, on the home lot of Morgan Bowers 72 rods, on the river 18 rods, and on John Birchard land 74 rods.

Rev. Huntington's book of "Old Houses of the Ancient Town of Norwich" names 36 men whom he suppose to have been original proprietors; but one of these was Richard Wallis and another was Caleb Abell, who in 1660 was only 14 years of age.

On Dec. 18, 1694 Caleb was appointed to keep his house as "an ordinari or of entertayment" for the year, or until another be chosen. Caleb joined the first church of Norwich before 1701. He was Sergeant of the Norwich Train Band in 1701; selectman in 1682; constable in 1684 and 1706; townsman in 1689.

In the book of Grants in Norwich, there are 38 or more land deeds granted to Caleb Abell, and only the following few will be given: Recorded December 11, 1710, ffour acres of meadow More or less in seven acre meadow with some swam-  
pie land bounded westerly on the highway with a bowing line and northerly upon meadow of Lieut. Joseph Backus and southerly upon the Commons and easterly upon the river, which was Given to Caleb Abell by his ffather (step-father) William Hide deceased and ordered to be recorded to him by John Post Executor to the will of sd Hide.

On Jan. 12, 1727/8, Caleb deeded to his son Noah, his home lot, dwelling house and barn, all lands adjoining his home lot and lands over the river (Yantic) his pasture land lying northerly and northeasterly of William Hide dwelling house (which house was on the other side of Town Street and a little to the east) lying in two parcels, together with land on both sides of Bradford brook on north side of road leading to Lebanon, except one and one half acres on soth east of breok and land near Benjamin Abell's dwelling house which he gave to his son Samuel, reserving to himself and his wife Marey the dwelling house during his life and for her's after his decease, also liberty to his daughter Hannah to dwell in said house so long as she remains unmarried and a passageway across home lot to his son Samuel to Samuel's own land.

William Backus, sold lot #14 on Town Street, in "Antient Windham" (Willimantic, Conn.) to Caleb Abell, Jan. 17, 1688 and Caleb later sold this lot to Robert Wade, June 6, 1696.





Another parcel were owned in Antient Windham by Caleb Abell, Nathaniel Rudd and John Hough. It appears that Caleb Abell bought this land in Willimantic, probably contemplating moving there but apperently did not.

Will of Sergt. Caleb Abell.

Caleb Abell of Norwich in the County of New London & Colony of Connecticut in New England being far advanced in years and apprehending my great change approching. Being also of Sound mind & perfect memory, do now make & ordain this my last Will and Testament viz on this 30 day of July Anno Dom 1728 to say as follows. I do Comply with ye Divine will and resign my Body to the Dust whence it was formed whenever God shall call me hence to be here no more & my Soul I do resign to God that gave it. And respecting such worldly Estate as God hath given me I do make the following Disposition.

Impr. As to my well beloved Wife Mary having already made provision for her Comfortable Maintenance after my decease, do hereby Confirm that and moreover do give unto her the Bed and Bedstead Bolster & Pillows Wc lies in the West Room together with one pair of sheets two Blankets & a Coverled and the Curtains wc belong to it; and also the use of the warming pan during her occasion for it.

Item. Respecting my Eldest Son Saml I have already by deeds of Gift given him that wc I have thot myself able to doand what I esteem as his proportion of my Estate. But as a token of my fatherly affection for him do also give him twenty shillings money.

Item. Respecting my son Caleb I have also done for him what I thot proper by Deeds of Gift & moreover do now as a token of my love Give him the sum of Twenty shillings.

Item. Respecting my son John I have also done for him what I thot proper by deeds of Gift & do also as token of my Love give him twenty shillings.

Item. Respecting the heirs of my son Theophilus deceased having before given him full proportion of my estate do now give unto them as a token of my Love ye sum of Twenty shillings.

Item. Respecting my son Noah wt I have already given him by deeds of Gift I do now Confirm and moreover do give unto him a pair of Oxen with the Cart yoke & chains & tackling belonging thereto, and also the one half of a ten acre Lot In the Sheepwalk to him & his heirs forever.

Item. Respecting my daughters Experience, Margaret, Johanna, Abigail, Hannah, I do give unto them equally an hundred acres of Lnd lying as Sutland in Windham to them & their heirs forever. The one half of my ten acre Lot in ye Sheepwalk I give unto my Daughter Hannah. I do give the Bed and bedding wc is in the East Room & Brass kettle a brass skillet and also a warming pan at her Mothers decease, and for her extraordinary servitude I do give her one great puter platter and two smaller ones and six puter plates to her & heirs forever. The Rest of all my Moveables I do give unto all my Children equally.

My Land at the Cranberry Pond I do order to be sold to pay the Debts & leave the disposal of it wth my Executors for that end, and I do appoint My Sons Samuel & Noah Executors of my Last Will & Testament.

Lieut. Stephen Post was b. in Chelmsford, Eng.; d.in Saybrook Aug. 16, 1659; m.Ellendor ----- at Cambridge in 1634. She was b.in Chelmsford, Eng., and d.Nov. 13, 1670. He came to America in the Griffen Sept. 4, 1633; freeman of Newton, Mass., in 1634; constable in Hartford in 1641 where he was one of the original proprietors; removed to Saybrook in 1647.

In the book of Grants of Norwich, Conn., there are recorded two parcels of land belonging to Caleb Abell of Lebanon.

On Feb.2, 1701/2, Caleb Abell, Jr., of Norwich, sold to William Hyde of Norwich, "all that parcel of land which was given to me by my Grandfather William Hide" and is lying and being upon the Northward corner of that which was his home lot and is by estimation two acres more or less bounded northerly and easterly on the highway and westerly and southerly on John Post and William Hide.

On Feb.8, 1703/4, Joshua Abell of Norwich, Yeoman, conveys 15 acres of land to Caleb Abell, Jr., of Lebanon, Mason.

On Apr.10, 1735, Margaret Abell Douglas, widow of New London and Hannah Abell of Norwich, conveys their rights in 40 acres of land to their honorable grandfather John Post of Norwich deceased, later Joshua Abell buys the rights to the same land from Caleb Abell, and Zachariah and Joanna Loomis.

From an address by Rev. Orlo d. Hine, on July 4, 1876 delivered at Lebanon; found in a book called "Early Lebanon", he says, that there is a tradition that the Abell house, which stood where Mr. Robert Peckham's house now stands, was a sort of a fort (stockade I conclude) to which the inhabitants fled in time of danger.

Caleb Abell was Constable of Lebanon in 1719, 1720, 1727 and 1732.



Caleb Abell, Junr.; was named as one of the executors of Joseph Sluman's will, which was made and proved on June 28, 1744 and Oct. 3, 1746.

Jonathan was in the campaign of 1758; French-Indian War, 1755-1762. Third Regiment, Col. Eleazer Fitch, First Company. He is said to have rendered service in the Revolution as a recruiting agent, probably without pay. He may have been the person recorded as mustered in under "Lincoln Men", Col. James Barrett's Regiment.

WRIGHT FAMILY: Mary Wright, who m. Nathaniel Bliss, was b. Mar. 9, 1675; dau. of Lieut. Abel Wright, who was b. in 1631; d. Oct. 29, 1725; m. Martha Kitcherel Dec. 1, 1659. Lieut. Abel Wright was located in Springfield in 1655. He was active in civil and Military service, and in 1695 was elected to the General Court. His wife was scalped by the Indians July 26, 1708 but lived until Oct. 19, 1708.

BURT FAMILY: Patience Burt, who m. John Bliss, was b. Aug. 18, 1645 in Springfield; d. Oct. 25, 1732; dau. of Henry Burt. Henry Burt of Harberton, co. Devon, Eng., and of Roxbury and Springfield, Mass., was b. about 1595; d. Apr. 30, 1662 at Springfield.; m. Ulalia (or Eulalia) March, at Dean Prior, co. Devon, Eng., Dec. 23, 1619; dau. of Richard and Joan Martyn (?) March. She d. Aug. 29, 1690 in Springfield, Mass. Henry emigrated to New England in 1638 or 1639. He was at Roxbury, Mass., where his house was burned; and the General Court made a grant of £8 to the town in Nov. 1639 because of this loss. In 1640 he removed to Springfield, where he was clerk of the writs and Selectman many years, was member of the first Military Company and clerk of the Company in 1657. He was the son of Henry Burt, of Harberton, co. Devon, Eng., clothier, who d. in 1617 and m. Isett (or Isott) -----, who survived her husband and d. in 1629-30.

HAZELTINE FAMILY: Bethiah Hazeltine, who m. Thomas Spofford, was b. May 16, 1682; dau. of Abraham Hazeltine. Abraham Hazeltine, was b. May 23, 1643 in Bradford, Mass.; d. Apr. 23, 1711-Bradford; m. Elizabeth Longhorne Oct. 7, 1671. Abraham was charter member of the Bradford Church, org. 1632, and Town Clerk of Bradford from 1636 to 1690. He was the son of Robert Hazeltine

Robert Hazeltine, d. Aug. 27, 1674 at Bradford, Mass.; m. Ann ----- Dec. 23, 1639 at Rowley, Mass. She d. July 26, 1684 at Bradford. He was the son of Peter Hazeltine, noted Puritan of Yorkshire, Eng. Robert and his brother John Hazeltine were at Salem, Mass. He was ferryman for several years.

BURPEE FAMILY: Sarah Burpee, who m. Samuel Spofford, was b. 12mo. 15, 1660; dau. of Thomas Burpee. Thomas Burpee, d. June 1, 1701; m. Martha -----, who d. June 24, 1658. He m. 2nd. Sarah Kelly Apr. 15, 1659; b. Feb. 12, 1641 in Newbury; d. Dec. 25, 1713; dau. of John Kelly. Thomas settled in Rowley.

SCOTT FAMILY: Elizabeth Scott, who m. John Spofford, was b. 1625 in Eng.; dau. of Thomas Scott, who was b. 1594; m. Elizabeth ----- She was b. 1594; d. 1683; m. 2nd. Ezekiel Rogers. They came in the ship "Elizabeth" the latter part of Apr. 1634 with their children.

KITCHEREL FAMILY: Martha Kitcherel, who m. Lieut. Abel Wright, d. Oct. 19, 1709; dau. of Samuel Kitcherel. Samuel





Kitcherel's wife m. Anothony Dorchester Jan. 1651. Samuel, probably son of Joseph Kitcherel, who on May 15, 1639, was given half acre of land at Winter Harbor, Salem, for fishing and was living at Charlestown.

LONGHORNE FAMILY: Elizabeth Longhorne, who m. Abraham Hazeltine, was b. Sept. 1649 at Rowley, Mass.; dau. of Richard Longhorne. Richard Longhorne, was b. in Eng., about 1617; d. Feb. 13, 1668/9 in Haverhill while there on business; m. Mary Crosby Jan. 1647/8. He and his brother Thomas were the immigrants. Richard was of Rowley in 1649.

CROSBY FAMILY: Mary Crosby, who m. Richard Longhorne, was bapt. Dec. 4, 1629, at Holme-on-Spalding-Moor, Yorkshire, Eng; bur. at Rowley Nov. 29, 1667; dau. of Robert Crosby. Robert Crosby, was bapt. Oct. 30, 1596; d. about 1640 at Holme-on-Spalding-Moor, Yorkshire, Eng.; m. Constance Brigham about 1622, in Holme-on-Spalding-Moor; bur. Jan. 25, 1633/4; dau. of Thomas and Isabel (Watson-Ellithorpe) Brigham. Isabel dau. of James Watson. Constance was a sister to Anne Brigham, who in 1634 m. Simon Crosby of Cambridge, Mass., a fourth cousin of her husband. Constance Crosby and her 3 children came to New England before 1643. She lived at Rowley, Mass. In 1674 she asked someone be appointed to care for her orphan granddaughter Sarah Longhorne.

- \*\* 9. JONATHAN ABELL, born May 31, 1767 at Lebanon, Conn.; bapt. July 19, 1767 in the Congregational Church of Lebanon-Columbia; died after 1830 in Duanesburgh Township, Schenectady County, New York; married Lucy Treadway about 1790, probably in Lebanon, Conn. She was born about 1767-69; died after 1830 in Duanesburgh Township, Schenectady County, New York.

Jonathan Abell is mentioned in the Census of 1810 as head of family in Columbia, Windham Co., Conn. (Lebanon town was geographically located in Windham County, Conn., in 1800, and Columbia town was organized from part of Lebanon town in 1804).

On Nov. 8, 1794, Jonathan bought one acre of land and part of a building and rights therein, which was bounded north on Capt. Samuel Jones' land, west on the highway and east on his father's land: Also, the new kitchen so-called with the chimney in it and cellar under it with cellar walls, except the east end which joins the west side of the house, also another small building adjoining the west side of the house and is called the shop room. Said old house being the same that Joseph Waters dec'd lived in and in which I now live, also the new part of said Dec'd barn being on the east end of the old barn with liberty of passing to said building and of taking them away or occupying them. The Grantor was Philemon Waters. No record found where he disposes of this property but presume he went with his father as this land joined his father's and it was sold together on Mar. 23, 1793. This property was located in Hebron, Conn.

Between the years 1810 and 1813, Jonathan with his family removed from Lebanon, Conn., to Duanesburgh Township, Schenectady County, N.Y., and settled on a farm.

On Oct. 5, 1813, Jonathan Abell, of Duanesburgh mortgaged to Silas Marsh for a part of a farm on Lot #243, in Duanesburgh. This property is located on the Albany-Buffalo Turnpike in Duanesburgh Township, about one mile from Esperance.



He and his wife were living in 1830, in Duanesburgh Township, as shown by the Federal Census of that year.

James Treadway, was b. Oct. 17, 1676; d. May 28, 1728, in Colchester, Conn.; m. Sarah Bond, Feb. 12, 1701-2. James was a Malster of Watertown. He was the son of Josiah Treadway.

Josiah Treadway, was b. in 1652; d. Jan. 15, 1733; m. Sarah Sweetman, Jan. 19, 1674. He m. 2nd. Dorothy Bell, Feb. 3, 1697-8; dau. of Abraham Bell. She m. 1st. Samuel Cutler. Josiah was a weaver a Watertown, Mass., and Freeman Apr. 18, 1690 in Charlestown. He was the son of Nathaniel Treadway.

Nathaniel Treadway, d. July 20, 1689, in Watertown, Mass.; m. Sufferance Haynes. She d. July 22, 1682 in Watertown; dau. of Walter and Elizabeth Haynes. Nathaniel was a weaver and settled first in Sudbury; proprietor in 1639, afterwards in Watertown where he was Selectman 7 years from 1653 to 1672. Nathaniel was granted land at Lake Quinsigamond in the year 1664 with John and Josiah Haynes, brothers to Sufferance Treadway. Walter and Elizabeth Haynes, came to this country from Sutton Mandifield, Wilts, Eng., with their children in 1638.

BOND FAMILY: Sarah Bond, who m. James Treadway, was b. Dec. 2, 1685; d. Feb. 17 or 28, 1753; dau. of Thomas Bond.

Thomas Bond, was b. Dec. 23, 1654; d. Dec. 17, 1704; m. Sept. 30, 1680, Sarah Woolson. He was the son of William Bond.

William Bond, was bapt. Sept. 3, 1625 in the Church of Bury St. Edmund, co. Suffolk, Eng.; d. Dec. 14, 1695. He was the son of Thomas and Elizabeth Bond.

Thomas Bond, of Bury St. Edmund, co. Suffolk, England, was bapt. Sept. 8, 1597.

SWEETMAN FAMILY: Sarah Sweetman, who m. Josiah Treadway, was b. May 2, 1654; d. Mar. 5, 1697; dau. of Thomas and Isabel Sweetman, of Cambridge. He was b. in 1610; d. Jan. 8, 1683. Freeman May 8, 1638.

WOOLSON FAMILY: Sarah Woolson, who m. Thomas Bond, was b. 1661; dau. of Thomas Woolson, of Cambridge 1653, of Watertown.



1660 and m. Sarah Hyde Nov, 20, 1660.

HYDE FAMILY: Sarah Hyde, who m. Thomas Woolson, was b. May 19, 1644; dau. of Dea. Samuel and Temperance Hyde, who was b. in 1610; d. Sept. 12, 1689 at Newton. William Bliss Abell was admitted a member and bapt. June 22, 1823, in the Esperance Presbyterian Church after being previously examined.

She with her Mother and others help to form the Esperance Presbyterian Church, on May 4, 1823, and was received from Duaneburgh. After 1835 she and her husband joined the Methodist Church of Esperance, N.Y.

Henry Edward Abell, left an orphan and thrown on his resources at the age of 14, managed by much diligence both at work at stores and in banks and at school when opportunity offered, to complete his education at the Delaware Literary Institute, Franklin, N.Y., Columbia University and as a law student in the office of the late Joseph H. Bradley, at Wash.

In 1864 he consolidated two papers under the name of "Schoharie-Union". William Knight, was b. Aug. 3, 1806; d. Apr. 25, 1839, at Esperance, N.Y.; m. Sarah O'Briant. She was b. Oct. 9, 1803; d. Dec. 14, 1865, at Esperance; dau. of John and Martha (Gordiner) O'Briant. He was the son of Philip Knight.

Philip Knight, was b. 1773; d. Dec. 21, 1856, at Esperance, N.Y.; m. Eunice -----, who was b. May 9, 1774; d. Feb. 18, 1836.

HEDGES FAMILY: Sarah Hedges, who m. Joseph Hunting, d. 1818; dau. of Daniel Hedges, who was b. 1709 and d. Apr. 12, 1766, son of William Hedges.

Mary Hedges, who m. Capt. Nathaniel Hunting, was bapt. Oct. 8, 1710; dau. of William Hedges.

William Hedges, was b. 1680; d. Nov. 4, 1768; m. Mar. 2, 1705, Abiah Mulford. He was the son of Daniel Hedges.

Daniel Hedges, was b. 1677; m. Sept. 30, 1703, Abigail





Baker. Daniel was of Sagg Harbor. He was the son of Stephen Hedges, who was b. July 7, 1634, and the son of William Hedges.

William Hedges, d. 1674; m. Rose ----. William was the immigrant. He was at East Hampton then removed to Southampton in 1644.

GREEN FAMILY: Mary Green, who m. Nathaniel Hunting, was b. about 1679; d. Oct. 7, 1733; dau. of John Green.

John Green, was b. June 1636; d. Mar. 3, 1690-1; m. Oct. 20, 1656, Ruth Mitchelson. She was b. Nov. 9, 1638, at Cambridge; dau. of Edward and Ruth (Bushell) Mitchelson. John and his wife were members of the church of Cambridge, Mass. He was chosen Marshall General and took the oath on June 3, 1681. He was the son of Percival Green.

Percival Green, was b. about 1603; d. Dec. 25, 1639, at Cambridge, Mass., m. Ellin -----. She was b. about 1600-3; d. May 27, 1682, at Cambridge. She m. 2nd. about 1650, Thomas Fox. Percival came to this country in 1635 on the Susan and Ellen. They were at Cambridge in 1636, and were both members of the Church.

Catherine Young, who m. John C. Knight, was b. June 18, 1832; d. Feb. 25, 1893; bur. in Esperance, N.Y.; dau. of Matthew Young.

Matthew Young, was b. Nov. 6 or 9, 1802; d. May 30, 1869, at Grosvenor Corners, Schoharie Co., N.Y.; m. Nancy McMillen. She was b. Apr. 22, 1806; d. July 17, 1873, at Grosvenor Cors. He was the son of Matthew Young.

Matthew Young, was b. Jan. 20, 1763; d. May 20, 1822. He was the first white child born in the present territory of Carlisle, N.Y. He was the son of Peter Young.

Peter Young, m. Aug. 2, 1745, Margaret Freymauer, in the St. Paul's Lutheran Church, at Schoharie, N.Y., prob. dau. of Michel and Elizabeth Freymauer, of Schoharie. Peter Young was one of the first settlers of Carlisle, Schoharie Co., N.Y. He hid his wife in a cave during an Indian and Tory raid without being discovered. She remained there for several days being supplied with provisions.

MULFORD FAMILY: Abiah Mulford, who m. William Hedges, was the dau. of Thomas Mulford. Thomas Mulford, was b. 1650-4, at East Hampton, N.Y.; d. Nov. 2, 1732, at East Hampton; m. Mary Conkling. He is described as a yeoman. He was the son of William Mulford.

William Mulford, was b. 1620, in Eng.; d. Mar. 1687, at East Hampton; m. Sarah Akers. He was one of the first settlers of East Hampton, 1649. He was a brother to Judge John Mulford.

CONKLING FAMILY: Mary Conkling, who m. Thomas Mulford, was b. 1658; d. June 15, 1743; dau. of Jeremiah Conkling, who was b. about 1635; d. Mar. 14, 1712-3; m. about 1658, Mary Gardiner. Jeremiah was the son of Ananias Conkling.

Ananias Conkling, was b. 1600 in Nottingham, Eng., d. 1657, at East Hampton; m. Feb. 23, 1631, Mary Launder. She was b. in Eng.; d. in Salem. He was one of the early settlers of Salem in 1637-8

GARDINER FAMILY: Mary Gardiner, who m. Jeremiah Conkling, was b. Aug. 30, 1638; d. June 15, 1727; dau. of Lieut. Lion Gardiner. Lieut. Lion Gardiner, was b. about 1599, in Eng.; d. 1663, at East Hampton, N.Y.; m. Marie Duercant. She was b. in Woerden in the Province of Holland, about 1601; d. 1665, at East Hampton; dau. of Dick Willemszen Duercant, son of William Dirckszen Duercant. They left Woerden for London on July 10, 1635 and soon afterwards proceeded to New England.



WING FAMILY: Margaret A. Wing, who m. Stephen Holland Abell, was b. Sept. 6, 1828, at Quaker Street, N.Y.; d. Apr. 22, 1913, in Duaneburgh Township, Schoenectady Co., N.Y., bur. in Esperance Cemetery, N.Y.; dau. of William Russell Wing and Jane Bolton.

William Russell Wing, was b. June 15, 1791, at Pawling, Dutchess Co., N.Y.; d. Feb. 24, 1879, at Maryville, Nodaway Co., Mo.; m. Phebe Cuthbert. He m<sup>2</sup>nd. July 14, 1825, Jane Bolton, in Great Barrington, Mass. He lived on a farm situated upon a slightly location one mile from Esperance, N.Y., on the Albany-Buffalo Turnpike, in Duaneburgh Township. He at one time owned the old Hotel at Quaker Street, it was burned in 1875. Removed to Maryville, Mo., in 1871. He was the son of Russell Wing.

Russell Wing, was b. 6th mo. 12, 1754, at Quaker Hill, Dutchess Co., N.Y.; m. Nancy Fields, June 27, 1787, in New Fairfield, Conn. He was reported for marrying out of meeting 16th, 7 mo. 1787, Oblong Monthly Meeting, Pawling, Dutchess Co., N.Y. Russell was taken from his birth under the care of William and Elizabeth Russell, receiving their name. In 1790 he was living at Pawling (Quaker Hill) and removed to Glen Falls, N.Y. He was the son of Edward Wing and Content Wood.

Edward Wing, was b. July 27, 1727, in Dartmouth, Mass.; d. at advanced age; m. Content Wood, before 1750. He m<sup>2</sup>nd. Hannah Hoag, 8th mo. 23, 1758, dau. of David and Keziah Hoag. Edward at an early period, before 1754, followed his brother Abraham to the Oblong, Dutchess Co., N.Y., and settled there. About 1793 he removed to Glen Falls, N.Y. Russell was a saddle and harness maker. He was the son of Edward Wing and Sarah Tucker.

Edward Wing, was b. 7th mo. 10, 1687, at Sandwich, Mass.; d. 1734, at Dartmouth, Mass., m. 11th mo. 1713, Desire Smith. He m<sup>2</sup>nd. 6th mo. 1, 1717, Sarah Tucker. He m<sup>3</sup>rd. Dec. 25, 1728, Patience Ellis, dau. of Freeman Ellis. She m<sup>2</sup>nd. William Wood, whose dau. Anstis and Content married Abraham and Edward Wing. Edward went to Dartmouth and settled there and collected a great property. In 1725-6 Edward was elected a Constable of Dartmouth. He was the son of Daniel Wing.

Daniel Wing, was b. 1mo. 28, 1664; d. 3rd. mo. 1740; m. Deborah Dillingham in 1686. He was admitted a townsman in Sandwich in 1691. He deeded on May 13, 1717, 100 acres of land in Dartmouth to his son Edward. He was the son of Daniel Wing and Hannah Swift.

Daniel Wing, was b. about 1617; d. Mar. 10, 1697-8 in Sandwich, Mass.; m. Dec. 5, 1641, Hannah Swift. He m<sup>2</sup>nd. 6th mo. 2, 1666, Anna Ewer, dau. of Thomas and Sarah (Learned) Ewer. Daniel lived at Saugus and came to Sandwich in 1637 and acquired his first homestead July 28, 1640. On June 1, 1669, Daniel Wing and Thomas Gibbs were appointed surveyors of the highways. He was the son of Rev. John Wing.

Rev. John Wing, was bapt. Jan. 12, 1584, in the Church of St. Marys, in Banbury, Eng.; d. about 1630, in London; son of Matthew and Mary Wing, of Banbury, Eng.; m. about 1609-10, Deborah Bachilor. Rev. John was a graduate of Queen's College, Eng. Fully 15 years of the lives of John Wing and his wife were spent in Germany and Holland as practical exiles from their native England. His widow and his children returned to Holland after his death. Deborah and her four sons sailed on the William and Francis from London, Mar. 1632, arrived in



Boston Harbor, America, June 5, 1632. Deborah Bachiler, was b.1592; living in 1648; dau. of Rev. Stephen Bachiler and his first wife. Rev. Stephen Bachiler, was b.1561, at Hackney, near London, Eng.; d.in 1660, at Hackney, Middlesex Co., Eng. His first wife's name is unknown. He m2nd. Helen -----, b. 1583; d.1642-4. He m3rd. Mary -----, of Portsmouth, abt.1648.

BOLTON FAMILY: Jane Bolton, who m. William Russell Wing, was b. July 14, 1801, at Colerain, Mass.; d. May 23, 1857 in Duaneburgh Township, Schenectady Co., N.Y.; dau. of Dr. Thomas Bolton. Dr. Thomas Bolton, was b. about 1774; d. before May 10, 1834, bur. in Alford Cemetery, Mass.; m. Fanny Clark. Dr. Thomas was living in Columbia Co., N.Y., in 1823, and in Egremont, Mass., in 1825, and appears to have lived there in 1832. He was the son of Dr. Thomas Bolton and Mary McClanathan.

Dr. Matthew Bolton, was b. 1732; d. June 5, 1774, at Colerain; m. Hannah McClanathan. She d. Dec. 28, 1761. He m2nd. Mary McClanathan, Oct. 9, 1762, at Palmer, Mass. Both his wives were the daus. of Dea. Thomas and Jane McClanathan, of Palmer, Mass. Dr. Matthew practiced medicine in Colerain. He bought land in two 50 acres lots of Hugh Bolton on June 6, 1761 and Apr. 18, 1769. He was the son of Dr. Hugh Bolton.

Dr. Hugh Bolton, was b. 1687, prob. in Ireland; d. June 8, 1772, at Colerain; m. Elizabeth Patterson, prob. in Eng. She was drowned in Deerfield River, Jan. 30, 1755. Dr. Hugh came from Tamlaght O'Crilly, Ireland, about 1730; settled first in Londonderry, N.H., where he bought land in 1733. He afterwards lived in Peterbore, N.H., coming to Colerain in 1741.

FIELDS AND SHERWOOD FAMILIES: Nancy Fields, who m. Russell Wing, was the dau. of William Fields and Hannah Sherwood, of New Fairfield, Conn. Hannah Sherwood, was the dau. of John Sherwood, who d. before 1768, and m. Hannah Morehouse, who was bapt. at Fairfield, Sept. 4, 1715. John was the son of Isaac Sherwood.

Isaac Sherwood, m. Mary -----. She d. 1748. Isaac settled in Norwalk. He was the son of Thomas Sherwood and Ann Turney.

Thomas Sherwood, was b. about 1624; m. Sarah Wheeler, dau. of Thomas Wheeler. He m2nd. by 1659, Ann Turney, dau. of Benjamin and Mary Turney. She was b. about 1637. He m3rd. Elizabeth Cable, widow of John Cable. He m4th. Sarah (Hide) Coley, widow of Peter Coley and dau. of Humprey Hide. Thomas Inventory was dated Mar. 12, 1698.

WOOD FAMILY: Content Wood, who m. Edward Wing, was b. Jan. 10, 1726; d. 1754; dau. of William Wood and Hannah Shaw.

William Wood, was b. Feb. 7, 1700, at Little Compton, R.I.; d. 1778, at Dartmouth, Mass.; m. Aug. 14, 1718, Hannah Shaw, at Little Compton. He m2nd. Sept. 29, 1737, Patience (Ellis) Wing, dau. of Freeman Ellis and widow of Edward Wing. William Wood was a glazier from Little Compton and removed to Fairhaven then a part of Dartmouth. It appears that he moved later to Dutchess Co., N.Y. William Wood's will dated May 14, 1773, Codicil to will dated Jan. 14, 1778. He was the son of Thomas Wood.

Thomas Wood, was b. 1666, at Little Compton, R.I.; d. May 10, 1729; m. in 1690, Content -----. Thomas was of Little Compton, that part called Seconett. His will dated Aug. 22, 1728. He was the son of John Wood.

John Wood, was b. 1620; d. 1704, aged 84; m. Mary Peabody.



John was a Freeman of Newport in 1655; listed for Grand Jury on Mar. 11, 1661; Deputy to General Assembly, Newport, 1673, 74, 75, 89 and 90. Deeded two lots, 50 acres each, to son Thomas on Nov. 14, 1695, in Little Compton. He was the son of John Wood.

John Wood, was b. prob. in Eng.; d. 1655; m2nd. Elizabeth. John was a member of the town council of Portsmouth, Jan. 10, 1648 and sued by John Richman for trespass on June 7, 1643, in Newport, R.I.

TUCKER FAMILY: Sarah Tucker, who m. Edward Wing, was b. Apr. 23, 1693; d. 5th. mo. 2, 1727; dau. of Abraham Tucker and Mary Slocum.

Abraham Tucker, was b. Oct. 13 or 30, 1653; d. Apr. 26, 1725; m. Mary Slocum, Oct. 30, 1679, dau. of Giles and Mary Slocum. He m2nd. Nov. 26, 1690, Hannah Mott. Abraham was one of the early proprietors of Dartmouth. He was the son of Henry Tucker.

Henry Tucker, was b. about 1619, in Eng.; d. Apr. 21, 1694, at Dartmouth; prob. son of Robert Tucker, of Weymouth. He m. Jan. 9, 1651-2, Martha ----- . She d. Nov. 28, 1675, at Newport, R.I. Henry was one of the early settlers at Dartmouth, where he was Surveyor of Highway in 1671 and 1675. On Oct. 28, 1684, some 4 men of Dartmouth brought suit against 36 Dartmouth proprietors, among whom was Henry Tucker.

DILLINGHAM FAMILY: Deborah Dillingham, who m. Daniel Wing, was b. Mar. 21, 1659; dau. of Henry Dillingham.

Henry Dillingham, was bapt. Oct. 13, 1624, at Cottesbach, Leicestershire, Eng.; d. July 26, 1705, at Sandwich; m. June 24, 1652 or Dec. 15, 1651, Hannah Perry. She d. June 9, 1673. Henry came to America in 1632 with his father and removed with him from Lynn to Sandwich in 1637, where he passed the remainder of his life. Freeman 1701 and 1702. He was the son of Edward Dillingham.

Edward Dillingham, was bapt. Dec. 6, 1595, at Cottesbach, Leicestershire, Eng.; d. at Sandwich between May 1, 1666 and June 5, 1667; son of Rev. Henry Dillingham, of Cottesbach, Leic. Eng., who was the son of William Dillingham. Edward m. Feb. 14, 1614, Ursula Carter, at Cottesbach. She d. Feb. 6, 1656 and bur. Feb. 9, in Sandwich. Edward came over in the ship William Francis, arriving at Boston in 1632 and very soon afterwards settled in Lynn, Mass., later at Sandwich.

SWIFT FAMILY: Hannah Swift, who m. Daniel Wing, d. Jan. 1, 1664, at Sandwich, Mass.; dau. of William Swift.

William Swift, was b. in Eng.; d. about 1641; m. Joan -----, in Eng. She d. 1662 or 63. In 1634 William was proprietor of Watertown, Mass., and removed in 1637 to Sudbury. He was in Lieut. John Blackmer's Co., Sandwich, in 1643.

CLARK FAMILY: Fanny (or Finnell or Phinwell) Clark, who m. Dr. Thomas Bolton, was b. Aug. 20, 1779, at Colerain, Mass.; d. 1848; bur. in the Alford Cemetery, Mass.; dau. of Capt. Matthew Clark.

Capt. Matthew Clark, was b. Sept. 30, 1744, at Colerain, Mass.; d. Apr. 18, 1813, at Colerain; m. Jane or Jean Workman, at Colerain. Capt. Matthew settled in Colerain. Proceedings upon the estate of Capt. Matthew Clark were made in Colerain on June 22, 1823. He was Sergeant in Capt. Robert Oliver's Co., Col. Ephraim regt; receipt for advance pay dated Charlestown, June 27, 1775, also, company return dated Winter Hill





Oct. 6, 1775, and in Capt. Hugh McClellan's Co., Col. David Field's regt. He was the son of Matthew Clark.

Matthew Clark, was b. about 1700, in Ireland; d. May 10, 1746, at Colerain, Mass.; m. Jennett Bothwell or Bothel. She was b. in 1703, at Great Britian; d. May 1739; dau. of Alexander and Jane (Doneca) Bothwell. Alexander Bothwell, came from Ireland in 1719, with Capt. Dennis, and settled in Rutland, Mass., and his wife Jane, died on the voyage to America. Matthew Clark came to America with his father in 1718 and settled in Colerain, Mass. He was shot by the Indians. He was the son of Lieut. John Clark.

Lieut. John Clark, m. Agnes Adams. He was the son of John Clark and Anne Horseman, dau. of the Mayor of Carrickfergus, Ireland. John Clark, was the son of William Clark, of Grange, co. Antrim, Ireland.

Lieut. John Clark came to America with Rev. M. Boyd in 1713, from the north of Ireland, with his seven sons. He settled in Worcester, Rutland and Colerain. He bought land in Colerain on Feb. 9, 1738 and in 1745. Won his Lieutenancy in the French and Indian War. He d. in South Hadley, Mass, aged 90 years.

MOREHOUSE FAMILY: Hannah Morehouse, who m. John Sherwood, was bapt. Sept. 4, 1715, at Fairfield; dau. of Thomas Morehouse, who d. Sept. 6, 1748, at Westport and m. Mary ----. She d. Dec. 20, 1753, at Westport. Thomas bought in 1721 property east of the Sangatuck River, Westport, and in 1732 bought 50 acres in Norwalk, where he settled. He was the son of Thomas Morehouse and ----- Keeler.

Thomas Morehouse, m. the eldest dau. of Ralph Keeler, of Norwalk. Ralph Keeler was b. in 1613; d. in 1672; m. Sarah Whelpley, widow of Henry Whelpley. Thomas m2nd. Martha Hobby. She was bapt. Nov. 1, 1696, at Fairfield; dau. of John Hobby. Thomas was the son of Thomas Morehouse.

Thomas Morehouse, d. in 1658; m. Isabelle Keller. He came from Eng., in 1653, and settled early in Wethersfield, removed to Stamford in 1640-1 and later to Fairfield. He was Deputy in the General Court of Hartford.

SHAW AND TALLMAN FAMILIES: Hannah Shaw, who m. William Wood, was b. Mar. 7, 1699, in Little Compton, R.I.; d. Dec. 22, 1734, in R.I.; dau. of Israel Shaw.

Israel Shaw, was b. in 1660; m. in 1689, dau. of Peter Tallman and Joan Briggs. Israel bought land in Portsmouth on Feb. 11, 1707. He was the son of Anthony Shaw. Peter Tallman, was b. 1622 or 1623; d. in 1708; m. Jan. 2, 1649, Ann Hill, in the Island of Barbados, dau. of Philip and Ann Hill. Peter m2nd. in 1665, Joan Briggs, of Taunton. She d. about 1635. Peter m3rd. about 1636, Esther -----. She d. in 1703. Peter Tallman came from Hambrough to the Island of Barbados in 1647, and removed to Rhode Island in 1650. Witness to a deed on July 16, 1674. Freeman of Newport 1655

Anthony Shaw, d. Aug. 21, 1705; m. Apr. 3, 1653, Alice Stonard, in Boston; dau. of John Stonard, prob. of Roxbury. Anthony may have been related to the Shaw family of Ovenden, Eng. He lived in Boston and after his marriage he settled in Portsmouth. His Inventory was taken on Oct. 1, 1705.

PEABODY FAMILY: Mary Peabody, who m. John Wood, was prob. the dau. of John Peabody, of Newport, R.I. John was b. 1612, prob. in Eng.; d. in 1687; m. Dorothy Tooley. He m2nd. Mary



Rogers, about 1677. She d. in 1678 and was the widow of James Rogers. John Peabody came early to Newport, bought land there in 1649.

MOTT FAMILY: Hannah Mott, who m. Abraham Tucker, was b. Nov. 1663, in Portsmouth, R.I.; d. in 1730; dau. of Jacob Mott.

Jacob Mott, was b. 1633, prob. in Eng.; d. Nov. 15, 1711; m. about 1661, Joanna Slocum. Jacob was Deputy from Portsmouth in 1674. He was in the King Philip's War. Constable in 1687. On Aug. 28, 1705, deeded land to his son Jacob. He was the son of Adam Mott.

Adam Mott, was b. in 1596, in Eng.; d. in 1661, in Portsmouth, R.I.; son of John Mott. Adam's first wife unknown. He m2nd. about 1632, Sarah Lott, in Eng. She was b. in 1604 in Eng.; d. after 1661. Adam was a tailor from Cambridge, Eng., came to America in 1635 on the ship Defence. He was made Freeman in Roxbury, Mass., on May 25, 1636 and Freeman of Portsmouth in 1655.

PERRY FAMILY: Hannah Perry, who m. Henry Dillingham, d. June 9, 1673; dau. of Sarah Perry, prob. widow of Edmund Perry, who d. before his wife emigrated to America.

WORKMAN FAMILY: Jane or Jean Workman, who m. Capt. Matthew Clark, was b. Feb. 20, 1759, in Colerain, Mass.; d. Apr. 17, 1813, in Colerain; dau. of John Workman.

John Workman, b. prob. in Ireland; d. in Colerain; m. Phoebe Stewart. They lived in Colerain. He was the son of Mr. Workman and Mary McCrellis, who was b. 1705; d. May 11, 1802.

SLOCUM FAMILY: Joanna Slocum, who m. Jacob Mott, was b. May 16, 1642, in Portsmouth; d. Jan. 6, 1727-8; dau. of Giles Slocum.

Giles Slocum, d. in 1682, in Portsmouth, R.I.; m. Joan ----. She d. Aug. 31, 1679, in Portsmouth. Land was granted to Giles Slocum on Sept. 4, 1648 in Portsmouth. Freeman 1655, He was the son of Philip Slocum. Philip Slocum's will was da. July 21, 1610, prov. Feb. 2, 1610-11. He m. Charity Bickman, Nov. 20, 1621, at Old Cleeve, co. Somerset, Eng. She was the dau. of Aldred and Ellen (Colles) Bickman. Res. in England.

STEWART FAMILY: Phoebe Stewart, who m. John Workman, was b. Jan. 28, 1731-2, in Concord, Mass.; dau. of James Stewart. James Stewart, was b. in 1680; d. Sept. 20, 1773, in Colerain, Mass.; m. Jane -----. She was b. in 1699; d. Sept. 18, 1777, in Colerain. About 1742, James Stewart is described as a wig maker, coming from Concord to Colerain. He bought land in Colerain in 1742.



OTTEN FAMILY: Katherine Otten, who m. Walter Wing Abell, was b. Dec. 11, 1855, at Schenectady, N.Y.; dau. of John Carl Otten.

John Carl Otten, was b. May 1, 1822, in Rommerskirchen, Neuss, Dusseldorf, Germany; d. Aug. 1863, at Schenectady, N. Y., U.S.A.; m. Aug. 28, 1847, Marie Theresa Koenen, in Paffendorf, Bergheim, Cologne, Germany. He was a Wood Wagon Maker in Germany. They emigrated to America from Germany in 1853, with his brother, Mathias, and his wife's mother, Elizabeth (Weitz) Koenen, who died at Sea. They resided at Albany and Schenectady, where both died and buried. He was the son of John Adam Otten and Marie Catherine Heusgen.

The following families lived in Germany:

John Adam Otten, was b. Jan. 14, 1792, at Rommerskirchen; d. Nov. 15, 1874, at Rommerskirchen; m. Marie (Anna) Catherine Heusgen, Jan. 6, 1821, at Rommerskirchen. He m<sup>2nd</sup>. Anna Abels, (Obels), June 22, 1840, in Rommerskirchen, dau. of Godfried and Catherine (Nuesser) Abels. He m<sup>3rd</sup>. Anna Catherine Engels, Jan. 5, 1843, in Rommerskirchen, dau. of Jacob and Catherine (Duester) Engels. He was a Carpenter and Master Millwright. He was the son of Adam Otten.

Adam Otten, was b. Dec. 6, 1757, at Rommerskirchen; d. June 6, 1820, at Rommerskirchen; m. Agnes Brewer, Mar. 6, 1791, at Cologne. He was a Carpenter and Joiner and they lived in Rommerskirchen. He was the son of Peter Otten.

Peter Otten, was b. July 24, 1721, at Rommerskirchen; d. Oct. 8, 1775, at Rommerskirchen; m. Catherine Wolff, Feb. 28, 1753, at Rommerskirchen. He was the son of Adam Otter (Otten).

Adam Otter (Otten), was a tailor at Gill. He was b. Oct. 3, 1676, at Rommerskirchen; d. May 30, 1740, at Rommerskirchen; m. Anne Esser, Sept. 1, 1699, at Rommerskirchen. When Adam Otter was married in 1699 he gave his name as Adam Otten. He was the son of John Otter (Otten).

John (Johannes) Otter, was a tailor at Gill. He was b. Aug. 27, 1648, at Rommerskirchen; m. Gertrude Hensen, Aug. 28, 1674, at Rommerskirchen. He was the son of John Otter.

John Otter, was known by the name of "Bach Jan" - Brook John, living at the brook. His wife Gertrudis or Druitgen (Gertrude), being a stranger at Gill, is first denoted "of Butgen", her native place, then by her family name "Meisen", at last by her occupation Quiltmaker. They had 5 children, born in Rommerskirchen: Elizabeth, b. 1647; John, b. 1648; Gertrudis, b. 1650; Mary, b. 1652 and John Adam, b. 1655.

KOENEN FAMILY: Marie Theresa Koenen, was b. May 29, 1823, at Paffendorf, Bergheim, Cologne; d. in 1910, at Schenectady, N.Y.; dau. of Constantin Koenen.

Constantin Koenen, was b. Feb. 14, 1779, at Glesch; d. Aug. 1, 1847, at Paffendorf; m. Elizabeth Weitz, Nov. 23, 1807, at Paffendorf. She died and was buried at Sea while in voyage to America from Germany in 1853, with her daughter and her daughter's husband, John Carl Otten. Constantin was a Mason. He was the son of Jacob Koenen.

Jacob Koenen, was bapt. in Paffendorf; m. Marie Brewers, Nov. 18, 1774, at Glesch-Paffendorf. She was bapt. in Paffendorf, dau. of Johannis and Marie Agnes (Hassetts) Brewers, of Glesch. Jacob was the son of Constantin Coenen (Koenen) and Anna Catharina Wintzens, of Glesch.

HEUSGEN (HEUSGES) FAMILY: Marie (Anna) Catherine Heusgen, who m. John Adam Otten, was bapt. Feb. 7, 1792, in the pas-



torage of St. Aldegund, Buttgen; d. June 11, 1836, at Rommerskirchen; dau. of John Theodorick Heusgen.

John Theodorick Heusgen, was b. Nov. 19, 1753, at Rommerskirchen; d. Sept. 26, 1819, at Rommerskirchen; m. Anna Mary (Marie) Feusges, Jan. 13, 1781. John was an Alderman and Church Warden. He was the son of Paul Heusgen & Anne Knaben.

Paul Heusgen, was bapt. June 13, 1709, at Buttgen; d. Dec. 14, 1794, at Buttgen; m. Anne Mary (Marie) Knaben. She d. Jan. 13, 1790, at Buttgen, dau. of John Theodorick Knaben, who d. Apr. 15, 1763, at Buttgen. Paul m2nd. Agnes Schmitz. He was the son of Gerhardus Heusgen.

Gerhardus Heusgen, was bapt. Apr. 3, 1681, at Buttgen; m. Caecilian (Cecilia) Eiker, June 27, 1708, at Buttgen. She was the dau. of William and Elizabeth (Bressers) Eiker, who was the son of Theodor and Gertrud Eiker. Gerhardus was the son of Paulus Heusges (Heusgen) and Gertrude Keyzers.

Paulus Husges, was bapt. Sept. 21, 1655, at Buttgen; m. Gertrude Keyzers, Mar. 3, 1680, at Buttgen. She was the dau. of Paulus and Gertrud Keiser. Paulus Heuges m2nd. Anna Rippen-gardner. He was the son of Gerardo Husges and Catharina (Weiller) Heusges, a miller in Buttgen.

BREWER FAMILY: Agnes Brewer, who m. Adam Otten, was b. Dec. 23, 1755, at Allrath; d. Nov. 20, 1832, at Rommerskirchen; dau. of Christian Brewer.

Christian Brewer, was bapt. Jan. 10, 1718, at Wavelinghoven; d. Feb. 16, 1789, at Allrath; son of Goswinus Brewer (Breuers) and Mary Frolig (Frolingh). Mary Frolig d. July 9, 1734, at Wavelinghoven. Christian m. Catharine Gappertz, Oct. 11, 1745, at Wavelinghoven. He m2nd. Mary Sibylla Schiffers, Feb. 7, 1748, at Allrath. She was bapt. Nov. 20, 1721, at Allrath; d. Aug. 12, 1773, at Allrath; dau. of Henry and Agnes (Schmitz) Schiffers. Henry Schiffers, son of Jan and Lisbeth Schiffer or Heydemans. Christian m3rd. Gertrudis Butgen, widow, at Allrath, Nov. 14, 1773.

WOLFF FAMILY: Catherine Wolff, who m. Peter Otten, was b. Mar. 6, 1726; d. June 26, 1788, at Rommerskirchen; dau. of Hilger Wolff.

Hilger Wolff, d. Dec. 12, 1727, at Dotzdorf; m. Mary Spix, of Dotzdorf, She was b. Oct. 2, 1691; d. June 27, 1762, at Rommerskirchen; dau. of Winand Spix. Winand Spix, was b. Nov. 7, 1651, at Rommerskirchen, son of Henry and Elizabeth (Kremers) Spix. Winand m. Ottilis Bonneschranz, Oct. 20, 1682, at Rommerskirchen, dau. of Christian and Cecilia (Hengers) Bonneschranz, who was the son of John Bonneschranz and Niefs (Agnes) of Gor (Gohr).

ESSER FAMILY: Anne Esser, who m. Adam Otter, was b. Apr. 15, 1678; d. Sept. 27, 1741, at Rommerskirchen; dau. of Peter Esser. Peter Esser, was b. July 17, 1664, at Rommerskirchen, son of Conrad and Sophia Esser. Peter m. Elizabeth Decker. She was b. Apr. 23, 1647, at Rommerskirchen, dau. of William Decker and Merge Storcks of Rheidt.

WEITZ FAMILY: Elizabeth Weitz, who m. Constantin Koenen, was bapt. Apr. 11, 1785, at Paffendorf; dau. of Peter Weitz. Peter Weitz, was b. 1733; m. Catherina Thums (Thoms), May 2, 1769, at Paffendorf, dau. of Wilhelm Henrice and Elisabeth (Kemmerlings) Thoms, of Glesch. Peter, son of Casper Weitz and Christina Bernards.


